Dear Parent/Guardian,

Murrumbeena Primary School is looking forward to another great year of teaching and learning and would like to advise you of Murrumbeena Primary School's voluntary financial contributions for 2026.

Schools provide students with free instruction to fulfil the standard curriculum requirements and we want to assure you that all contributions are voluntary.

We want to thank you for all your support, whether that's through making payment contributions, fundraising or volunteering your time. This has made a huge difference to our school and the programs and facilities we offer.

**Attached to this letter is the Education Department Parent Payments Policy.** This policy outlines that instruction is provided free of charge for students in Government schools however stationery, textbooks, digital devices, subscriptions etc are additional costs that schools can ask parents to contribute to (see curriculum contributions).

The School Council Finance Committee has reviewed the voluntary parent contributions and despite increased supplier costs has decided not to increase the contributions.

Within our school, parent contributions have allowed us to continue to enhance the learning environment and to offer a wide range of programs to capture the varied interests of our students. Parent contributions have allowed us to:

- Offer the **'Stephanie Alexander Kitchen Garden'** program which enables students to grow, harvest, prepare and share food through gardening and cooking classes with specialised staff. It should be noted that the Education Department does NOT provide additional funding for schools to run the SAKG program so without parent financial contributions, the program is simply not possible.
- **Continue to create open learning spaces**, both indoors and outdoors with furnishings and fittings designed for creativity, communication and collaboration. Parent voluntary contributions enable the school to continue to improve its grounds and facilities. Last year we installed the synthetic turf and veranda outside the learning centre and hall, a new playground for year 3-6 and the rollover bars in the quiet area. This year we installed barrier netting behind the junior football posts, junior netball rings and a retaining wall behind the portables.
- **Parent contributions will enable us to complete our plans to increase shade/ weather protection** in the school. The Facilities School Council subcommittee is currently planning the installation of the COLA; a covered outdoor learning area based on the feedback from the 2024 community consultation.

### **Financial Support for Families**

Murrumbeena Primary School understands that some families may experience financial difficulty and offers a range of support options, including:

- Camps, Sports and Excursions Fund

The program provides capped payments for eligible students to attend camps, sports and excursions. If eligible, a payment of \$150 per child is payable to the school which can be applied to the above activities for 2024.

- State Schools Relief (SSR) Applications are submitted by schools. The program covers costs such as new school uniform, shoes and socks.

# PARENT PAYMENTS POLICY

## ONE PAGE OVERVIEW



### FREE INSTRUCTION

- Schools provide students with free instruction and ensure students have free access to all items, activities and services that are used by the school to fulfil the requirements of the Curriculum. This includes the Victorian Curriculum F-10, the Victorian Certificate of Education (VCE) including the VCE Vocational Major and the Victorian Pathways Certificate.
- Schools may invite parents to make a financial contribution to support the school.



### PARENT PAYMENT REQUESTS

Schools can request contributions from parents under three categories:

#### Curriculum Contributions

Voluntary financial contributions for curriculum items and activities which the school deems necessary for students to learn the Curriculum.

#### Other Contributions

Voluntary financial contributions for non-curriculum items and activities that relate to the school's functions and objectives.

#### Extra-Curricular Items and Activities

Items and activities that enhance or broaden the schooling experience of students and are above and beyond what the school provides for free to deliver the Curriculum. These are provided on a user-pays basis.

- Schools may also invite parents to supply or purchase educational items to use and own (e.g. textbooks, stationery, digital devices).



### FINANCIAL HELP FOR FAMILIES

- Schools put in place financial hardship arrangements to support families who cannot pay for items or activities so that their child doesn't miss out.
- Schools have a nominated parent payment contact person(s) that parents can have a confidential discussion with regarding financial hardship arrangements.



### SCHOOL PROCESSES

- Schools must obtain school council approval for their parent payment arrangements and publish all requests and communications for each year level on their school website for transparency.
